WHAT IS IHRA?



The International Holocaust Remembrance Alliance (IHRA) was established in 1998 to promote Holocaust education, remembrance, and research worldwide. IHRA has cultivated relationships with governments and academics to combat global antisemitism and ensure the implementation of Holocaust education.

THE IHRA WORKING DEFINITION OF ANTISEMITISM



One of the most significant contributions of the group is its "Working Definition of Antisemitism," adopted in May 2016. This definition provides a clear and practical framework for identifying and understanding antisemitic acts. It states:

"Antisemitism is a certain perception of Jews, which may be expressed as hatred toward Jews. Rhetorical and physical manifestations of antisemitism are directed toward Jewish or non-Jewish individuals and/or their property, toward Jewish community institutions and religious facilities."

The definition includes examples to illustrate what constitutes antisemitism, such as[1]:

- Calling for, aiding, or justifying the killing or harming of Jews.
- Making mendacious, dehumanizing, demonizing, or stereotypical allegations about Jews.
- Denying the fact, scope, mechanisms, or intentionality of the Holocaust.
- Accusing Jewish citizens of being more loyal to Israel than to the interests of their own nations.
- Applying double standards to Israel by requiring behavior not expected or demanded of any other democratic nation.



Policy: The IHRA definition provides a framework to build policies and laws to combat antisemitism, allowing there to be legal implications for those who engage in antisemitism associated with an underlying unlawful act.
